Pricing agreements may be modified at any time without notice, due to non-compliance of the terms set for in this application.

ACCEPTANCE OF DELIVERY

The company delivers fuel to its customers in two specific manners: (1) automatic delivery and (2) call-in.

Delivery tickets accepted by the customer or their authorized representative will constitute rebuttable proof that the fuel was delivered at the time and in the quantity showing on the ticket.

Customers are requested to designate to Cuyahoga Landmark, Inc. upon the opening of this account a satisfactory conspicuous place on their premises for the posting of the delivery ticket by the driver, in the event no authorized person is on the premises to accept delivery. If no such place is designated in writing to the company, the driver will attempt to post the delivery ticket in the most conspicuous place, but the driver will not be responsible for the discovery of the ticket absent a customer designation.

If within forty-eight (48) hours of the acceptance by the authorized person of the fuel delivery or of the posting of the delivery ticket, the customer has not notified Cuyahoga Landmark, Inc. of any failure of delivery or deficiency in the delivery, the customer will be held responsible for payment for the full amount of the delivery shown on the delivery ticket and their account will be charged accordingly.
